"AN ACT PROHIBITING THE SALE OF DOGS AND CATS OBTAINED FROM SUBSTANDARD DOMESTIC ANIMAL MILLS AND REQUIRING A STANDARD OF CARE APPLICABLE TO ANIMAL IMPORTERS."

Strike section 1 in its entirety and insert the following in lieu thereof:
"Section 1. (NEW) (Effective July 1, 2013) On and after January 1, 2016, no pet shop licensed pursuant to section 22-344 of the general statutes, as amended by this act, shall sell or transfer a dog or cat or allow a dog or cat to be sold, adopted out, or otherwise transferred to the public on the premises of such pet shop unless such dog or cat was obtained from: (1) A publicly operated animal control facility, or (2) an animal shelter or rescue organization that is a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, or any subsequent corresponding internal revenue code of the United States, as from time to time amended, whose primary mission and practice is the rescue and placement of abandoned, unwanted, neglected or abused animals. Any person who violates the provisions of this section shall be fined not more than five hundred dollars."
