**"AN ACT CONCERNING THE DEPARTMENT OF CHILDREN AND FAMILIES AND THE PROTECTION OF CHILDREN."**

1 Strike section 6 in its entirety and insert the following in lieu thereof:

2 "Sec. 6. Subsection (b) of section 17a-101 of the 2014 supplement to  
3 the general statutes is repealed and the following is substituted in lieu  
4 thereof (*Effective October 1, 2014*):

5 (b) The following persons shall be mandated reporters: (1) Any  
6 physician or surgeon licensed under the provisions of chapter 370, (2)  
7 any resident physician or intern in any hospital in this state, whether  
8 or not so licensed, (3) any registered nurse, (4) any licensed practical  
9 nurse, (5) any medical examiner, (6) any dentist, (7) any dental  
10 hygienist, [or] (8) any psychologist, [a] (9) any school employee, as  
11 defined in section 53a-65, (10) social worker, (11) any person who  
12 holds or is issued a coaching permit by the State Board of Education, is  
13 a coach of intramural or interscholastic athletics and is eighteen years  
14 of age or older, (12) any paid coach or director of youth athletics who

15 is eighteen years of age or older, (13) any paid coach or director of a  
16 private youth sports organization, league or team who is eighteen  
17 years of age or older, (14) any paid administrator, faculty, staff, athletic  
18 director, athletic coach or athletic trainer employed by a public or  
19 private institution of higher education who is eighteen years of age or  
20 older, excluding student employees, (15) any police officer, (16) any  
21 juvenile or adult probation officer, (17) any juvenile or adult parole  
22 officer, (18) any member of the clergy, (19) any pharmacist, (20) any  
23 physical therapist, (21) any optometrist, (22) any chiropractor, (23) any  
24 podiatrist, (24) any mental health professional, [or] (25) any physician  
25 assistant, (26) any person who is a licensed or certified emergency  
26 medical services provider, (27) any person who is a licensed or  
27 certified alcohol and drug counselor, (28) any person who is a licensed  
28 marital and family therapist, (29) any person who is a sexual assault  
29 counselor or a domestic violence counselor, as defined in section  
30 52-146k, (30) any person who is a licensed professional counselor, (31)  
31 any person who is a licensed foster parent, (32) any person paid to care  
32 for a child in any public or private facility, child day care center, group  
33 day care home or family day care home licensed by the state, (33) any  
34 employee of the Department of Children and Families, (34) any  
35 employee of the Department of Public Health who is responsible for  
36 the licensing of child day care centers, group day care homes, family  
37 day care homes or youth camps, (35) any paid youth camp director or  
38 assistant director, (36) the Child Advocate and any employee of the  
39 Office of the Child Advocate, and (37) any family relations counselor,  
40 family relations counselor trainee or family services supervisor  
41 employed by the Judicial Department."
