**"AN ACT CONCERNING THE GOVERNOR'S
RECOMMENDATIONS REGARDING ELECTRONIC NICOTINE
DELIVERY SYSTEMS AND YOUTH SMOKING PREVENTION."**

1 After the last section, add the following and renumber sections and
2 internal references accordingly:

3 "Sec. 501. Subsection (c) of section 4-28e of the 2014 supplement to
4 the general statutes is repealed and the following is substituted in lieu
5 thereof (*Effective from passage*):

6 (c) (1) For the fiscal year ending June 30, 2001, disbursements from
7 the Tobacco Settlement Fund shall be made as follows: (A) To the
8 General Fund in the amount identified as "Transfer from Tobacco
9 Settlement Fund" in the General Fund revenue schedule adopted by
10 the General Assembly; (B) to the Department of Mental Health and
11 Addiction Services for a grant to the regional action councils in the
12 amount of five hundred thousand dollars; and (C) to the Tobacco and
13 Health Trust Fund in an amount equal to nineteen million five
14 hundred thousand dollars.

15 (2) For the fiscal year ending June 30, 2002, and each fiscal year
 16 thereafter, disbursements from the Tobacco Settlement Fund shall be
 17 made as follows: (A) To the Tobacco and Health Trust Fund in an
 18 amount equal to twelve million dollars; [, except in the fiscal years
 19 ending June 30, 2014, and June 30, 2015, said disbursement shall be in
 20 an amount equal to six million dollars;] (B) to the Biomedical Research
 21 Trust Fund in an amount equal to four million dollars; (C) to the
 22 General Fund in the amount identified as "Transfer from Tobacco
 23 Settlement Fund" in the General Fund revenue schedule adopted by
 24 the General Assembly; and (D) any remainder to the Tobacco and
 25 Health Trust Fund.

26 (3) For each of the fiscal years ending June 30, 2008, to June 30, 2012,
 27 inclusive, the sum of ten million dollars shall be disbursed from the
 28 Tobacco Settlement Fund to the Stem Cell Research Fund established
 29 by section 19a-32e for grants-in-aid to eligible institutions for the
 30 purpose of conducting embryonic or human adult stem cell research.

31 Sec. 502. Section 109 of public act 13-184 is repealed. (*Effective from*
 32 *passage*)"

This act shall take effect as follows and shall amend the following sections:
