(c) Proof of identity satisfactory to the department. Such proof must include one of the following documents issued to the applicant:

1. A driver license record or identification card record from another jurisdiction that required the applicant to submit a document for identification which is substantially similar to a document required under subparagraph 2., subparagraph 3., subparagraph 4., subparagraph 5., subparagraph 6., subparagraph 7., or subparagraph 8.;
2. A certified copy of a United States birth certificate.;
3. A valid, unexpired United States passport.;
4. A naturalization certificate issued by the United States Department of Homeland Security - $^{\boldsymbol{\prime}}$
5. A valid, unexpired alien registration receipt card (green card) $\dot{\text { - }}$
6. A Consular Report of Birth Abroad provided by the United States Department of State.; ${ }^{\boldsymbol{\prime}}$
7. An unexpired employment authorization card issued by the United States Department of Homeland Security.; or

8. Proof of nonimmigrant classification provided by the United States Department of Homeland Security, for an original driver license. In order to prove nonimmigrant classification, an applicant must provide at least one of the following documents. In addition, the department may require applicants to produce United States Department of Homeland Security documents for the sole purpose of establishing the maintenance of, of efforts to maintain, continuous lawful presence:
a. A notice of hearing from an immigration court scheduling a hearing on any proceeding.
b. A notice from the Board of Immigration Appeals acknowledging pendency of an appeal.
c. A notice of the approval of an application for adjustment of status issued by the United States Citizenship and Immigration Services.
d. An official documentation confirming the filing of a petition for asylum or refugee status or any other relief issued by the United States Citizenship and Immigration Services.
e. A notice of action transferring any pending matter from another jurisdiction to this state issued by the United States Citizenship and Immigration Services.
f. An order of an immigration judge or immigration officer granting relief which that authorizes the alien to live and work in the United States, including, but not limited to, asylum.
g. Evidence that an application is pending for adjustment of status to that of an alien lawfully admitted for permanent

residence in the United States or conditional permanent resident status in the United States, if a visa number is available having a current priority date for processing by the United States Citizenship and Immigration Services.
h. On or after January 1, 2010, an unexpired foreign passport with an unexpired United States Visa affixed, accompanied by an approved I-94, documenting the most recent admittance into the United States.

In addition to the documents required under this subparagraph, the department may require applicants to provide United States Department of Homeland Security documents for the sole purpose of establishing the maintenance of, or efforts to maintain, continuous lawful presence.
9. A passport or birth certificate issued by a foreign government.
10. A consular identification document issued by the government of Mexico, or a document issued by another government which the department determines is substantially similar.

A driver license or temporary permit issued based on documents required in subparagraph $7 .$, ox subparagraph 8., subparagraph 9., or subparagraph 10. is valid for a period not to exceed the expiration date of the document presented or 1 year.
(d) Whether the applicant has previously been licensed to drive, and, if so, when and by what state, and whether any such 649629

license or driving privilege has ever been disqualified, revoked, or suspended, or whether an application has ever been refused, and, if so, the date of and reason for such disqualification, suspension, revocation, or refusal.
(e) Each such application may include fingerprints and other unique biometric means of identity.

Section 3. Subsection (1) of section 322.12, Florida Statutes, is amended to read:
322.12 Examination of applicants.-
(1) It is the intent of the Legislature that every applicant for an original driver license in this state be required to pass an examination pursuant to this section. However, the department may waive the knowledge, endorsement, and skills tests for an applicant who is otherwise qualified, except for an applicant who provides proof of identity under s. $322.08(2)(c) 9$. or s. $322.08(2)(c) 10 .$, and who surrenders a valid driver license from another state or a province of Canada, or a valid driver license issued by the United States Armed Forces, if the driver applies for a Florida license of an equal or lesser classification. Any applicant who fails to pass the initial knowledge test incurs a $\$ 10$ fee for each subsequent test, to be deposited into the Highway Safety Operating Trust Fund. Any applicant who fails to pass the initial skills test incurs a $\$ 20$ fee for each subsequent test, to be deposited into the Highway Safety Operating Trust Fund. A person who seeks to retain a hazardous-materials endorsement, pursuant to s.

322.57(1)(e), must pass the hazardous-materials test, upon surrendering his or her commercial driver license, if the person has not taken and passed the hazardous-materials test within 2 years before applying for a commercial driver license in this state.

Section 4. Paragraph (c) of subsection (1) of section 322.14, Florida Statutes, is amended, paragraph (d) is added to subsection (1), and subsection (3) is added to that section, to read:
322.14 Licenses issued to drivers.-
(1)
(c) The word "Veteran" shall be exhibited on the driver license of a veteran upon the payment of an additional \$1 fee for the license and the presentation of a copy of the person's DD Form 214, issued by the United States Department of Defense, or another acceptable form specified by the Department of Veterans' Affairs. Until a veteran's license is next renewed, the veteran may have the word "Veteran" added to his or her license upon surrender of his or her current license, payment of a $\$ 2$ fee to be deposited into the Highway Safety Operating Trust Fund, and presentation of a copy of his or her DD Form 214 or another acceptable form specified by the Department of Veterans' Affairs. If the applicant is not conducting any other transaction affecting the driver license, a replacement license shall may be issued with the word "Veteran" without payment of the fee required in s. $322.21(1)(e)$.

(d) The department shall include symbols representing the following on a driver license upon the payment of an additional $\$ 1$ fee by an applicant who meets the requirements of s. 322.08 and presents his or her:

1. Lifetime freshwater fishing license;
2. Lifetime saltwater fishing license;
3. Lifetime hunting license;
4. Lifetime sportsman's license; or
5. Lifetime boater safety identification card.

A person may replace his or her driver license before its expiration date with a license that includes his or her status as a lifetime licensee or boater safety cardholder upon surrender of his or her current driver license, payment of a $\$ 2$ fee to be deposited into the Highway Safety Operating Trust Fund, and presentation of the person's lifetime license or identification card. If the sole purpose of the replacement driver license is the inclusion of the applicant's status as a lifetime licensee or cardholder, the replacement driver license must be issued without payment of the fee required in s. 322.21(1)(e).
(3) If the United States Department of Homeland Security notifies the department of a final deadline by which this state must fully comply with the REAL ID Act of 2005, Pub. L. No. 10913, ss. 201-202, and determines that the state is otherwise in full compliance with the act, the department shall mark all
