MR. SPEAKER:

I move that House Bill 1273 be amended to read as follows:

- 1 Page 7, line 12, after "16." insert "(a)".
- 2 Page 7, line 26, delete "may" and insert "**must**".
- 3 Page 7, line 27, delete "noncontiguous" and insert "**only**
- 4 **contiguous**".
- 5 Page 7, between lines 27 and 28, begin a new paragraph and insert:
- 6 "**(b) A hotel described in subsection (a)(1) that is included within**
- 7 **the additional professional sports development area may not be**
- 8 **financed by debt issued by or assumed by the capital improvement**
- 9 **board, the facilities authority, or a political subdivision.**".
- 10 Page 8, between lines 2 and 3, begin a new line block indented and
- 11 insert:
- 12 "**(4) In addition to any findings required under subdivisions**
- 13 **(1) through (3) if the terms of a tax area are revised, the**
- 14 **commission must also make findings concerning the following**
- 15 **if the terms of a tax area are revised:**
- 16 **(A) The reason or purpose for a revision in the terms of the**
- 17 **tax area.**
- 18 **(B) The fiscal impact of the revision in the terms of the tax**
- 19 **area to each affected political subdivision and to the state,**
- 20 **including an estimate of the fiscal impact during the time**
- 21 **in which bonds issued under this chapter will be**

1 outstanding.
 2 (C) The need for and the proposed use of any additional
 3 revenue that will be raised by the revision in the terms of
 4 the tax area.

5 The Marion County city-county council may by ordinance specify
 6 the maximum number of times that the terms of a tax area may be
 7 changed."

8 Page 8, line 15, delete "Upon" and insert "At least thirty (30) days
 9 before the".

10 Page 8, line 17, after "notice of the" insert "proposed".

11 Page 8, line 24, delete "benefits" and insert "impacts".

12 Page 8, between lines 28 and 29, begin a new line triple block
 13 indented and insert:

14 "(iii) The estimated loss of jobs, if any, and the estimated
 15 loss of assessed valuation for each political subdivision,
 16 if any."

17 Page 8, line 41, delete "make the following findings:" and insert "do
 18 the following:".

19 Page 8, line 42, delete "The" and insert "Find that the".

20 Page 9, line 2, delete "The" and insert "Find that the".

21 Page 9, line 7, delete "The" and insert "Find that the".

22 Page 9, line 9, after "improvement." insert "If the resolution is for
 23 a change of a tax area, the findings under this subdivision must
 24 specifically describe the resources committed by the political
 25 subdivisions toward the completion of the improvement."

26 Page 9, between lines 9 and 10, begin a new line block indented and
 27 insert:

28 "(4) Determine if the political subdivisions affected by the
 29 project specified in the resolution will be negatively affected
 30 financially or economically by the project or the
 31 establishment of the improvement."

32 Page 11, line 29, after "the" insert "county executive and".

33 Page 11, line 29, after "must" insert "approve the lease and".

34 Page 12, line 16, after "improvement" delete "," and insert ", if all
 35 financial obligations by the sublessee to the capital improvement
 36 board have been fulfilled;".

37 Page 18, delete lines 11 through 19, begin a new paragraph and
 38 insert:

39 "Sec. 42. Not more than thirty (30) days after a final resolution
 40 is adopted to issue bonds under this chapter, a person may appeal
 41 the decision of the facilities authority to issue the bonds by filing a
 42 petition with the commission and the Marion County city-county
 43 council. If a petition is filed under this section, the commission shall
 44 hold a hearing on the petition. The commission shall approve or
 45 disapprove the issuance of the bonds. If the commission does not
 46 approve the issuance of the bonds, the bonds may not be issued. If

1 **the commission approves the issuance of the bonds, the bonds may**
2 **be issued only if the Marion County city-county council adopts a**
3 **resolution approving the issuance of the bonds."**
