



SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1273 be amended to read as follows:

- 1 Page 10, between lines 34 and 35, begin a new line block indented
- 2 and insert:
- 3 **"(4) The minority and women's participation plan adopted**
- 4 **under section 6 of this chapter has been reviewed by the**
- 5 **budget committee."**
- 6 Page 11, after line 42, begin a new paragraph and insert:
- 7 **"Sec. 6. (a) As used in this section, "minority business**
- 8 **enterprise" has the meaning set forth in IC 4-13-16.5-1.**
- 9 **(b) As used in this section, "plan" means a minority and**
- 10 **women's participation plan adopted under this section.**
- 11 **(c) As used in this section, "women's business enterprise" has**
- 12 **the meaning set forth in IC 4-13-16.5-1.3.**
- 13 **(d) In addition to any other requirements that apply under state**
- 14 **law, the trustees of Indiana University shall adopt a minority and**
- 15 **women's participation plan for capital improvement projects**
- 16 **under this chapter.**
- 17 **(e) The following apply to a plan adopted under this section:**
- 18 **(1) The plan must include goals for the participation of**
- 19 **minority business enterprises and women's business**
- 20 **enterprises in the capital improvement projects. These goals**
- 21 **must be at least equal to the participation goals that apply to**
- 22 **other capital improvement projects undertaken by Indiana**
- 23 **University. However, the plan must specifically address the**
- 24 **extent to which it is feasible to implement greater**
- 25 **participation goals in order to reflect the number of minority**
- 26 **business enterprises and women's business enterprises in the**
- 27 **community in which the capital improvement project will**
- 28 **undertaken.**

1 (2) The plan must identify the actions that the university will
2 take in its efforts to achieve the participation goals under
3 subdivision (1) and to provide employment opportunities for
4 individuals residing in the community in which the capital
5 improvement project will be undertaken. These actions must
6 include outreach programs to:

7 (A) inform businesses and individuals about the
8 participation goals under subdivision (1) and the
9 employment opportunities for individuals; and

10 (B) assist businesses and individuals in taking advantage of
11 these opportunities under the participation goals and
12 employment opportunities.

13 (3) The plan must provide that one (1) or more individuals or
14 private contractors must be dedicated to coordinating and
15 overseeing the efforts under subdivision (2) to meet the
16 participation goals and to provide employment opportunities
17 for individuals residing in the community in which the capital
18 improvement project will be undertaken.

19 (f) The plan must be reviewed by the budget committee before
20 bonds may be issued under this chapter.

21 (g) The university must report quarterly to the budget
22 committee, the governor's commission on minority and women's
23 business enterprises, and the legislative council (in an electronic
24 format under IC 5-14-6) regarding the following:

25 (1) The planned and actual participation of minority business
26 enterprises and women's business enterprises in the capital
27 improvement projects.

28 (2) The activities undertaken under subsection (e)(2)
29 concerning efforts to achieve the participation goals and to
30 provide employment opportunities."
