MR. SPEAKER:

I move that House Bill 1273 be amended to read as follows:

- 1 Page 4, line 15, delete "and".
- 2 Page 4, line 22, delete "." and insert "; and
- 3 **(3) the only county admissions tax rate that events described**
- 4 **in section 1(b) of this chapter are subject to is the county**
- 5 **admissions tax rate imposed under this section."**
- 6 Page 7, line 12, delete "A" and insert "Subject to subsection (b), a".
- 7 Page 7, line 26, delete "may" and insert "must".
- 8 Page 7, line 27, delete "noncontiguous" and insert "only
- 9 **contiguous"**.
- 10 Page 7, line 27, after "county." insert "The power of eminent
- 11 **domain may not be exercised by the commission, the capital**
- 12 **improvement board, the facilities authority, or any political**
- 13 **subdivision to acquire property within the tax area."**
- 14 Page 7, between lines 27 and 28, begin a new paragraph and insert:
- 15 **"(b) The geographic area to be included within a tax area is**
- 16 **subject to approval by the Marion County city-county council.**
- 17 **(c) A hotel described in subdivision (1) that is included within**
- 18 **the additional professional sports development area may not be**
- 19 **financed by debt issued by or assumed by the capital improvement**
- 20 **board, the facilities authority, or a political subdivision."**
- 21 Page 7, line 32, after "area." insert "Any changes to a tax area or

1 to the terms of a tax area are subject to approval by the Marion
2 County city-county council."

3 Page 8, between lines 2 and 3, begin a new line block indented and
4 insert:

5 **"(4) In addition to any findings required under subdivisions**
6 **(1) through (3) if the terms of a tax area are revised, the**
7 **commission must also make findings concerning the following**
8 **if the terms of a tax area are revised:**

9 **(A) The reason or purpose for a revision in the terms of the**
10 **tax area.**

11 **(B) The fiscal impact of the revision in the terms of the tax**
12 **area to each affected political subdivision and to the state,**
13 **including an estimate of the fiscal impact during the time**
14 **in which bonds issued under this chapter will be**
15 **outstanding.**

16 **(C) The need for and the proposed use of any additional**
17 **revenue that will be raised by the revision in the terms of**
18 **the tax area.**

19 **The Marion County city-county council may by ordinance specify**
20 **the maximum number of times that the terms of a tax area may be**
21 **changed."**

22 Page 8, line 9, after "chapter" delete "," and insert **"and approval**
23 **of the resolution by the Marion County city-county council,"**

24 Page 8, line 15, delete "Upon" and insert **"At least thirty (30) days**
25 **before the"**.

26 Page 8, line 17, before "adoption" insert **"proposed"**.

27 Page 8, line 24, delete "benefits" and insert **"impacts"**.

28 Page 8, between lines 28 and 29, begin a new line triple block
29 indented and insert:

30 **"(iii) The estimated loss of jobs, if any, and the estimated**
31 **loss of assessed valuation for each political subdivision, if**
32 **any."**

33 Page 9, line 9, after "improvement." insert **"The findings under this**
34 **subdivision must specifically describe the resources committed by**
35 **the political subdivisions toward the completion of the**
36 **improvement."**

37 Page 9, between lines 9 and 10, begin a new line block indented and
38 insert:

39 **"(4) The political subdivisions affected by the project specified**
40 **in the resolution will not be negatively affected financially or**
41 **economically by the project or the establishment of the**
42 **improvement."**

43 Page 9, line 38, after "department" insert **"and the Marion County**
44 **city-county council"**.

45 Page 11, line 29, after "the" insert **"county executive and"**.

46 Page 11, line 29, after "must" insert **"approve the lease and"**.

1 Page 12, line 16, after "improvement" delete ";" and insert ", **if all**
2 **financial obligations by the sublessee to the capital improvement**
3 **board have been fulfilled;**".

4 Page 12, line 29, after "(8)" insert "**must specify that the facilities**
5 **authority owns the capital improvement, and**".

6 Page 18, delete lines 11 through 19, begin a new paragraph and
7 insert:

8 "**Sec. 42. Not more than thirty (30) days after a final resolution**
9 **is adopted to issue bonds under this chapter, a person may appeal**
10 **the decision of the facilities authority to issue the bonds by filing a**
11 **petition with the commission and the Marion County city-county**
12 **council. If a petition is filed under this section, the commission shall**
13 **hold a hearing on the petition. The commission shall approve or**
14 **disapprove the issuance of the bonds. If the commission does not**
15 **approve the issuance of the bonds, the bonds may not be issued. If**
16 **the commission approves the issuance of the bonds, the bonds may**
17 **be issued only if the Marion County city-county council adopts a**
18 **resolution approving the issuance of the bonds.**".
