## **HOUSE MOTION**

## MR. SPEAKER:

I move that Engrossed Senate Bill 333 be amended to read as follows:

1	Page 4, between lines 8 and 9, begin a new paragraph and insert:
2	"SECTION 6. IC 4-12-1-14.9, AS ADDED BY P.L.213-2015,
3	SECTION 46, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
4	UPON PASSAGE]: Sec. 14.9. (a) As used in this section, "account"
5	refers to the state bicentennial capital account established by
6	subsection (c).
7	(b) As used in this section, "bicentennial commission" refers to the
8	Indiana 2016 bicentennial commission established by IC 4-23-33-3.
9	(c) The state bicentennial capital account is established within the
10	state general fund for the purposes set forth in subsection (f). The
11	account shall be administered by the budget agency. The account
12	consists of the following:
13	(1) Money transferred to the account under IC 4-13-1-4(10) or
14	IC 8-15.5-1-2(g).
15	(2) Appropriations, if any, made by the general assembly.
16	(3) Grants and gifts intended for deposit in the account.
17	(4) Any earnings on money in the account.
18	(d) The expenses of administering the account shall be paid from
19	money in the account.
20	(e) Money in the account at the end of the state fiscal year does not
21	revert to the state general fund.

- 2 1 (f) Money in the account may be used only for capital projects that 2 commemorate the bicentennial of Indiana's statehood. 3 (g) The budget agency shall consult with the bicentennial 4 commission in making a determination to expend money from the 5 account for the purposes under subsection (f). 6 (h) This subsection applies before December 12, 2016. If the 7 budget agency determines that there is insufficient money in the 8 account to pay the obligations of the account, the budget agency 9 shall notify the governor. The governor may, after review by the 10 budget committee, request that an amount sufficient to meet the 11 obligations of the account be transferred from the state general 12 fund to the account. The total amount of money requested by the 13 governor under this subsection before December 12, 2016, is 14 appropriated to the budget agency for the purposes of the 15 account.". 16 Page 33, between lines 18 and 19, begin a new line block indented 17 and insert: 18 "(14) After making the distributions required under 19 subdivisions (1) through (13), twenty million dollars 20 (\$20,000,000) is appropriated to the Indiana economic 21 development corporation to make distributions of five million 22 dollars (\$5,000,000) to each applicant for the four (4) Indiana 23 regional cities projects that were not selected for funding 24 from the Indiana regional cities development fund established
  - (15) After making the distributions required under subdivisions (1) through (14), one hundred thousand dollars (\$100,000) is appropriated to the strategic review committee of the Indiana economic development corporation for its use in monitoring the effectiveness of the Indiana regional cities awards.
  - (16) After making the distributions required under subdivisions (1) through (15), three million six hundred thousand dollars (\$3,600,000) is appropriated for the office of the secretary of family and social services to provide adult protective services as provided in HEA 1001-2015, SECTION 8.".
