 - 7 "SECTION 2. [EFFECTIVE UPON PASSAGE] **(a) The definitions**
 - 8 **in IC 3-5-2 apply throughout this SECTION.**
 - 9 **(b) The Marion County circuit court clerk shall place the**
 - 10 **following public question on the November 2018 general election**
 - 11 **ballot in the county:**
 - 12 **"Shall the judges of the Marion County Superior Court be**
 - 13 **elected by the voters of Marion County in the same fashion as**
 - 14 **the judges of most other superior court judges in Indiana are**
 - 15 **elected?".**
 - 16 **(c) The county election board shall print the following**
 - 17 **immediately below the public question stated in subsection (b):**
 - 18 **"The vote on this question is only advisory. The result of the**
 - 19 **vote on this question is not binding on the Indiana General**
 - 20 **Assembly or any public official."**
 - 21 **(d) The county election board shall tabulate the votes cast on the**
 - 22 **public question described in this SECTION and certify the results**
 - 23 **under IC 3-12-4-9. The circuit court clerk shall send a copy of the**
 - 24 **certification required by this subsection to the following:**
 - 25 **(1) The speaker of the house of representatives.**
 - 26 **(2) The minority leader of the house of representatives.**
 - 27 **(3) The president pro tempore of the senate.**
 - 28 **(4) The minority leader of the senate.**
 - 29 **(5) The governor.**
 - 30 **(e) IC 3 applies to the public question placed on the ballot under**
 - 31 **this SECTION, to the extent IC 3 is not inconsistent with this**
 - 32 **SECTION.**
 - 33 **(f) This SECTION expires July 1, 2019."**
 - 34 Delete pages 11 through 14.
 - 35 Page 15, delete lines 1 through 18.
 - 36 Renumber all SECTIONS consecutively.
