



# SENATE MOTION

**MADAM PRESIDENT:**

**I move** that Senate Bill 61 be amended to read as follows:

- 1       Page 1, between the enacting clause and line 1, begin a new
- 2       paragraph and insert:
- 3       "SECTION 1. IC 20-20-40-11, AS ADDED BY P.L.122-2013,
- 4       SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 5       JULY 1, 2017]: Sec. 11. (a) The commission on seclusion and restraint
- 6       in schools is established.
- 7       (b) The commission has the following ~~nine (9)~~ **ten (10)** members:
- 8       (1) The designee of the state superintendent, who serves at the
- 9       pleasure of the state superintendent.
- 10      (2) A representative of the Autism Society of Indiana, chosen by
- 11      the organization, who serves a two (2) year term.
- 12      (3) A representative of the Arc of Indiana, chosen by the
- 13      organization, who serves a two (2) year term.
- 14      (4) A representative of the Indiana Council of Administrators of
- 15      Special Education, chosen by the organization, who serves a two
- 16      (2) year term.
- 17      (5) A representative of Mental Health America of Indiana, chosen
- 18      by the organization, who serves a two (2) year term.
- 19      (6) A parent of a student with a disability, nominated by a
- 20      member described in subdivisions (1) through (5) and approved
- 21      by a majority of the members described in subdivisions (1)
- 22      through (5), who serves a two (2) year term.
- 23      (7) A parent of a student who does not have a disability,
- 24      nominated by a member described in subdivisions (1) through (5)
- 25      and approved by a majority of the members described in
- 26      subdivisions (1) through (5), who serves a two (2) year term.
- 27      (8) One (1) accredited nonpublic school administrator nominated

1 by the Indiana Non-public Education Association, who serves a  
2 two (2) year term.

3 (9) One (1) public school superintendent nominated by the  
4 Indiana Association of Public School Superintendents, who serves  
5 a two (2) year term.

6 **(10) One (1) member of the National Association for School**  
7 **Resource Officers, chosen by the organization, who serves a**  
8 **two (2) year term.**

9 (c) Each member of the commission who is not a state employee is  
10 entitled to the minimum salary per diem provided by IC 4-10-11-2.1(b).  
11 A member who is not a state employee is also entitled to  
12 reimbursement for traveling expenses and other expenses actually  
13 incurred in connection with the member's duties, as provided in the  
14 state travel policies and procedures established by the Indiana  
15 department of administration and approved by the budget agency."

16 Page 3, line 36, delete "A school resource officer".

17 Page 3, line 37, delete "assigned to a" and insert "A".

18 Page 4, line 1, delete "in" and insert "**involving a school resource**  
19 **officer, in**".

20 Renumber all SECTIONS consecutively.
