

## **SENATE MOTION**

## **MADAM PRESIDENT:**

**I move** that Engrossed House Bill 1426 be amended to read as follows:

1	Page 12, delete lines 14 through 42.
2	Page 13, delete lines 1 through 19, begin a new paragraph and
3	insert:
4	"SECTION 11. IC 20-26-15-8, AS AMENDED BY SEA 354-2018,
5	SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
6	JULY 1, 2018]: Sec. 8. (a) The contract must contain the following
7	provisions:
8	(1) A list of the statutes and rules that are suspended from
9	operation in a freeway school corporation or freeway school, as
10	listed in section 5 of this chapter.
11	(2) A description of the privileges of a freeway school corporation
12	or freeway school, as listed in section 6 of this chapter.
13	(3) A description of the educational benefits listed in section 7 of
14	this chapter that a freeway school corporation or freeway school
15	agrees to:
16	(A) achieve by the end of five (5) complete school years after
17	the contract is signed; and
18	(B) maintain at the end of:
19	(i) the sixth; and
20	(ii) any subsequent;
21	complete school year after the contract is signed.
22	(4) Subject to section 15 of this chapter (before its expiration), a
23	plan and a schedule for the freeway school corporation or freeway
24	school to achieve the educational benefits listed in section 7 of
25	this chapter by the end of five (5) complete school years after the
26	contract is signed. The schedule must show some percentage of

1	improvement by the end of the second, third, and fourth complete
2	school years after the contract is signed.
3	(5) A school by school strategy, including curriculum, in which
4	character education is demonstrated to be a priority. The strategy
5	required under this subdivision must include the following
6	subjects as integral parts of each school's character education:
7	(A) Hygiene.
8	(B) Alcohol and drugs.
9	(C) Diseases transmitted sexually or through drug use
0	including AIDS.
1	(D) Honesty.
2	(E) Respect.
3	(F) Abstinence and restraint.
4	(6) A plan under which the freeway school corporation or freeway
5	school will offer courses that will allow a student to become
6	eligible to receive an Indiana diploma with a Core 40 with
7	academic honors diploma. designation.
8	(7) A plan under which the freeway school corporation or freeway
9	school will maintain a safe and disciplined learning environment
20	for students and teachers.
21	(b) In the contract:
.2	(1) the quantitative measures of benefits may be higher, but not
22 23 24 25	lower, than the minimum educational benefits listed in section 7
.4	of this chapter; and
	(2) educational benefits may be included in addition to the
26	minimum educational benefits listed in section 7 of this chapter.".
27	Renumber all SECTIONS consecutively.
