

## **SENATE MOTION**

## **MADAM PRESIDENT:**

**I move** that Engrossed House Bill 1385 be amended to read as follows:

1	Page 34, between lines 24 and 25, begin a new paragraph and insert:
2	"SECTION 58. IC 14-26-2.1 IS ADDED TO THE INDIANA CODE
3	AS A <b>NEW</b> CHAPTER TO READ AS FOLLOWS [EFFECTIVE
4	JULY 1, 2020]:
5	Chapter 2.1. Ownership of Lake Michigan in Public Trust
6	Sec. 1. As used in this chapter, "Lake Michigan" means:
7	(1) the waters of Lake Michigan;
8	(2) the land under the waters of Lake Michigan; and
9	(3) the land adjoining the waters of Lake Michigan up to the
10	ordinary high water mark;
11	within the boundaries of Indiana.
12	Sec. 2. As used in this chapter, "ordinary high water mark"
13	means the line on the bank or shore of Lake Michigan that is:
14	(1) established by the fluctuations of water; and
15	(2) indicated by physical characteristics, including:
16	(A) a clear and natural line impressed on the shore;
17	(B) shelving;
18	(C) changes in character of soils;
19	(D) the destruction of terrestrial vegetation; and
20	(E) the presence of litter or debris.
21	Sec. 3. (a) Absent any authorized legislative conveyance before
22	February 14, 2018, the state of Indiana owns all of Lake Michigan
23	within the boundaries of Indiana in trust for the use and enjoyment
24	of all citizens of Indiana.
25	(b) An owner of land that borders Lake Michigan does not have
26	the exclusive right to use the water or land below the ordinary high
27	water mark of Lake Michigan.
28	Sec. 4. (a) As used in this section, "natural scenic beauty" refers

1	to conditions produced by nature without manmade additions or
2	alterations.
3	(b) As used in this section, "recreational purpose" means any of
4	the following:
5	(1) Walking.
6	(2) Fishing.
7	(3) Boating.
8	(4) Swimming.
9	(5) Any other recreational purpose for which Lake Michigan
10	is ordinarily used, as recognized by the commission for the
1	purposes of this section.
12	(c) The citizens of Indiana have a vested right to:
13	(1) enjoy the natural scenic beauty of Lake Michigan;
14	(2) enjoy and use the natural resources of Lake Michigan; and
15	(3) use Lake Michigan for recreational purposes.
16	(d) The citizens of Indiana have a vested right in the
17	preservation and protection of Lake Michigan.
18	Sec. 5. The commission may adopt rules under IC 4-22-2 to
19	administer this chapter.
20	SECTION 59. IC 14-29-1-9 IS ADDED TO THE INDIANA CODE
21	AS A <b>NEW</b> SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
22	1, 2020]: Sec. 9. The department may adopt rules under IC 4-22-2
23 24	to identify the location of the ordinary high water mark on the land
	adjoining the waters of Lake Michigan for purposes of
25	administering this chapter.".
26	Renumber all SECTIONS consecutively.
