HB 1134 # 29

DIGEST

Study of certain mental health services. Removes the provision that establishes a consent procedure to be used before a school corporation or qualified school may provide or administer certain mental, social-emotional, or psychological services to a student. Urges the legislative council to assign to an appropriate interim study committee the task of studying the following: (1) The provision of services for mental, social-emotional, or psychological health issues in public schools by licensed psychologists or school psychologists or other employees of public schools. (2) Parental consent regarding the provision of the services.
