



SENATE MOTION

MADAM PRESIDENT:

I move that Engrossed House Bill 1134 be amended to read as follows:

- 1 Page 2, delete lines 6 through 42, begin a new paragraph and insert:
- 2 "SECTION 2. IC 20-23-18-3, AS AMENDED BY P.L.147-2020,
- 3 SECTION 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
- 4 JULY 1, 2022]: Sec. 3. (a) Except as provided in subsection (c), the
- 5 Muncie Community School Corporation is subject to all applicable
- 6 federal and state laws.
- 7 (b) If a provision of this chapter conflicts with any other law,
- 8 including IC 20-23-4, the provision in this chapter controls.
- 9 (c) Notwithstanding subsection (a), to provide all administrative and
- 10 academic flexibility to implement innovative strategies, the Muncie
- 11 Community School Corporation is subject only to the following IC 20
- 12 and IC 22 provisions:
- 13 (1) IC 20-26-5-10 (criminal history).
- 14 (2) IC 20-28-5-8 (conviction of certain felonies; notice and
- 15 hearing; permanent revocation of license; data base of school
- 16 employees who have been reported).
- 17 (3) IC 20-28-10-17 (school counselor immunity).
- 18 (4) IC 20-29 (collective bargaining) to the extent required by
- 19 subsection (e).
- 20 (5) IC 20-30-3-2 and IC 20-30-3-4 (patriotic commemorative
- 21 observances).
- 22 (6) The following:
- 23 (A) IC 20-30-5-0.5 (display of the United States flag; Pledge
- 24 of Allegiance).
- 25 (B) IC 20-30-5-1, IC 20-30-5-2, and IC 20-30-5-3 (the
- 26 constitutions of Indiana and the United States; writings,
- 27 documents, and records of American history or heritage).

 2 (D) IC 20-30-5-5 (morals instruction).
 3 (E) IC 20-30-5-6 (good citizenship instruction).

 36 (d) The Muncie Community School Corporation is subject to
 37 required audits by the state board of accounts under IC 5-11-1-9.
 38 (e) Except to the extent required under a collective bargaining
 39 agreement entered into before July 1, 2018, the Muncie Community
 40 School Corporation is not subject to IC 20-29 unless the school
 41 corporation voluntarily recognizes an exclusive representative under
 42 IC 20-29-5-2. If the school corporation voluntarily recognizes an
 43 exclusive representative under IC 20-29-5-2, the school corporation
 44 may authorize a school within the corporation to opt out of bargaining
 45 allowable subjects or discussing discussion items by specifying the
 46 excluded items on the notice required under IC 20-29-5-2(b). The

- 1 notice must be provided to the education employment relations board
2 at the time the notice is posted."
3 Delete pages 3 through 9.
4 Page 10, delete lines 1 through 17.
5 Page 10, delete lines 22 through 23, begin a new paragraph and
6 insert:
7 **"Sec. 1. As used in this chapter, "qualified school" means the**
8 **following:**
9 **(1) A school maintained by a school corporation.**
10 **(2) A charter school.**
11 **(3) A laboratory school established under IC 20-24.5-2.**
12 **(4) The Indiana School for the Blind and Visually Impaired**
13 **established by IC 20-21-2-1.**
14 **(5) The Indiana School for the Deaf established by**
15 **IC 20-22-2-1."**
16 Page 10, delete lines 40 through 42.
17 Delete pages 11 through 16.
18 Renumber all SECTIONS consecutively.
