DIGEST

Indiana state park inns authority. Adds a provision that allows the Indiana state park inns authority (authority) to purchase service credit (subject to certain conditions) for prior service by an employee of the authority. Defines "fund" and "member". Makes conforming changes.

16	employees' retirement fund.
17	Sec. 3.5. As used in this chapter, "member" means a person who
18	qualifies for membership under IC 5-10.3-7-1.".
19	Page 12, between lines 6 and 7, begin a new paragraph and insert:
20	"(b) In the resolution adopted under subsection (a), the
21	executive director may determine the date from which prior
22	service for an employee of the authority will be computed and
23	purchase the prior service subject to the following and in
24	accordance with this section:
25	(1) Before the member retires, the authority shall make
26	contributions to the fund that are equal to the product of the
27	following:
28	(A) The member's salary at the time of the service credit
29	purchase.
30	(B) A percentage rate, as determined by the actuary of the
31	fund, based on the age of the member at the time the
32	authority makes a contribution for service credit and
33	computed to result in a contribution amount that
34	approximates the actuarial present value of the benefit
35	attributable to the service credit purchased.
36	(C) The number of years of service credit that the
37	authority intends to purchase.
38	(2) Contributions for any accrued interest, at a rate
39	determined by the actuary of the fund, for the period from the
40	member's initial membership in the fund to the date payment

1	is made.
2	(c) The authority shall verify that the member's prior service is
3	valid.
4	(d) The board of trustees of the Indiana public retirement
5	system established by IC 5-10.5-3-1 may deny the purchase of
6	service credit if the purchase would exceed the limitations under
7	Section 415 of the Internal Revenue Code.
8	(e) The authority may fund prior member contribution amounts
9	described in IC 5-10.3-7-9(b) at an amount that may not exceed
10	three percent (3%) of the member's salary at the time the
11	contributions are made for each year of service purchased.
12	(f) The authority may submit contributions to the retirement
13	medical benefits account trust established by IC 5-10-8.5-11 based
14	on the year or years of service purchased.".
15	Page 12, line 7, delete "(b)" and insert "Sec. 19.5.".
16	Renumber all SECTIONS consecutively.
