Administrative rules review task force. Establishes the administrative rules review task force (task force). Provides duties for the task force.

6 **(3) How the issues described in subdivisions (1) and (2)**
 7 **compare to other states.**

8 **(4) Any other issues related to administrative rulemaking, as**
 9 **determined by the task force.**

10 **(b) The task force may request information or testimony from**
 11 **department or agency heads, or the designee of a department or**
 12 **agency head, as determined necessary by the task force.**

13 **Sec. 8. The task force shall:**

14 **(1) develop recommendations in a report for the general**
 15 **assembly concerning the issues set forth in section 7(a) of this**
 16 **chapter; and**

17 **(2) not later than December 1, 2022, submit the report to the**
 18 **executive director of the legislative services agency for**
 19 **distribution to the members of the general assembly. The**
 20 **report submitted to the executive director of the legislative**
 21 **services agency under this subdivision must be in an**
 22 **electronic format under IC 5-14-6.**

23 **Sec. 9. The legislative services agency shall provide support staff**
 24 **to the task force."**
