

PROPOSED AMENDMENT

SB 366 # 3

DIGEST

Higher education funding. Adds member appointments by the legislative council to the commission for higher education. Changes the term "performance based funding formula" to "outcomes based funding formula" throughout the bill. Changes the effective date of SECTION 5 of the bill regarding the state educational institution capital project state budget review process from July 1, 2022, to July 1, 2023. Makes a grammatical change.

- 1 Replace the effective date in SECTION 5 with "[EFFECTIVE JULY

- 9 **(1) Eleven (11) members** appointed by the governor as follows:
- 10 ~~(1) Each member must be a citizen of Indiana.~~
- 11 ~~(2) (A)~~ Each congressional district must be represented by at
- 12 least one (1) member who resides in the congressional district.
- 13 ~~(3) (B)~~ One (1) member must be a student.
- 14 ~~(4) (C)~~ One (1) member must be a full-time faculty member of
- 15 a state educational institution.
- 16 **(2) Four (4) members appointed by the legislative council**
- 17 **who:**
- 18 **(A) are not members of the general assembly; and**
- 19 **(B) represent the public at large.**
- 20 **(b) Each member must be a resident of Indiana."**
