

# PROPOSED AMENDMENT

## SB 376 # 5

### DIGEST

Qualified organization. Removes provisions in the bill that: (1) allow a qualified organization to accept credit cards for the purchase of licensed supplies or a chance to play any game of chance offered at an allowable activity; and (2) specify that certain credit card payments may be made on the Internet. Provides that a qualified organization and other specified individuals may accept payment by credit card for the purchase of a chance to enter a raffle or water race offered at an allowable activity if the transaction satisfies particular requirements.

- 1           Page 1, delete lines 1 through 17, begin a new paragraph and insert:  
2           "SECTION 1. IC 4-32.3-5-23, AS ADDED BY P.L.58-2019,  
3           SECTION 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
4           JULY 1, 2022]: Sec. 23. (a) Subject to ~~subsection~~ **subsections (b) and**  
5           **(c)**, a qualified organization may accept credit cards at an allowable  
6           activity for the purchase of:  
7                 (1) food and beverages;  
8                 (2) merchandise; and  
9                 (3) retail goods and services offered at a benefit auction.  
10           **(b) Except as provided in subsection (c)**, a qualified organization  
11           may not accept credit cards or extend credit to a player for the purchase  
12           of:  
13                 (1) a chance to play any game of chance offered at an allowable  
14                 activity; or  
15                 (2) licensed supplies.  
16           **(c) A qualified organization, including a worker, or a volunteer**  
17           **ticket agent assisting the qualified organization may accept**  
18           **payment by credit card for the purchase of a chance to enter a**  
19           **raffle or water race offered at an allowable activity if the**  
20           **transaction satisfies the following requirements:**  
21                 **(1) The payment is made face to face and not on the Internet.**  
22                 **(2) The proceeds from an entry purchased for the allowable**  
23                 **activity are used:**  
24                         **(A) by the qualified organization for the lawful purposes of**  
25                         **the qualified organization; or**

- 1                   **(B) to:**
- 2                    **(i) purchase a prize for; or**
- 3                    **(ii) pay prize money to;**
- 4                    **a winner of the allowable activity.**
- 5                   **(3) It is the only allowable activity in a calendar year for**
- 6                   **which the qualified organization accepts payment by credit**
- 7                   **card for a chance to enter a raffle or water race under this**
- 8                   **subsection. This subdivision does not limit the number of**
- 9                   **times that a person may purchase by credit card a chance to**
- 10                   **enter a raffle or water race under this subsection."**
