Regulation of radioactive material. Makes technical changes.

 - 17 **determination by the NRC, declares by order that the**
 - 18 **source would pose a threat similar to the threat posed by**
 - 19 **a discrete source of radium-226 to the public health and**
 - 20 **safety.**".
