MR. SPEAKER:

I move that House Bill 1086 be amended to read as follows:

- 1 Page 1, between the enacting clause and line 1, begin a new
- 2 paragraph and insert:
- 3 "SECTION 1. IC 7.1-1-3-13.7 IS ADDED TO THE INDIANA
- 4 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
- 5 [EFFECTIVE JULY 1, 2024]: **Sec. 13.7. "Craft manufacturer"**
- 6 **means a person who holds:**
- 7 **(1) a small brewery permit under IC 7.1-3-2-7(5);**
- 8 **(2) a farm winery permit under IC 7.1-3-12; or**
- 9 **(3) an artisan distiller's permit under IC 7.1-3-27."**
- 10 Page 1, line 12, after "(c)," insert **"a craft manufacturer and"**.
- 11 Page 2, line 7, after "permit" insert **"or a permit held by a craft**
- 12 **manufacturer"**.
- 13 Page 2, line 12, delete "The" and insert **"A craft manufacturer and**
- 14 **the"**.
- 15 Page 2, line 19, after "transfer" insert **"a permit held by a craft**
- 16 **manufacturer or"**.
- 17 Page 2, delete lines 24 through 27, begin a new paragraph and
- 18 insert:
- 19 **"(f) A:**
- 20 **(1) craft manufacturer that holds an active permit issued**
- 21 **before July 1, 2024; and**

- 1           **(2) holder of an active retailer's permit issued before July 1,**
- 2           **2024;**
- 3           **must comply with this section not later than January 1, 2025, or**
- 4           **the commission may suspend or revoke the permit. This subsection**
- 5           **expires July 1, 2027."**
- 6           Page 8, line 29, after "for" insert "**a craft manufacturer and**".
- 7           Page 8, line 32, after "that the" insert "**craft manufacturer or**".
- 8           Page 8, line 39, after "by the" insert "**craft manufacturer or**".
- 9           Page 9, line 2, after "for" insert "**a craft manufacturer and**".
- 10          Page 9, line 4, after "that the" insert "**craft manufacturer or**".
- 11          Page 9, line 6, after "for" insert "**a craft manufacturer and**".
- 12          Page 9, line 23, after "a" insert "**craft manufacturer or**".
- 13          Page 9, line 25, after "if the" insert "**craft manufacturer or**".
- 14          ReNUMBER all SECTIONS consecutively.
