

# PROPOSED AMENDMENT

## SB 142 # 3

### DIGEST

Mobile integrated healthcare programs. Limits reimbursement of emergency medical services to mobile integrated healthcare programs (programs) in certain counties that were operating before July 1, 2024. Limits the reimbursement for these programs for the period beginning July 1, 2024, and ending June 30, 2027. Requires the state personnel department and the department of insurance to report to the legislative council claims and reimbursement data concerning the reimbursement to these programs.

 32                **the reimbursement for emergency medical services as part of a**  
 33                **mobile integrated healthcare program under this section. The**  
 34                **report must include the following:**
