1 AMENDMENT NO. 1

2 On page 1, delete line 4 and insert:

3 "devices; to provide relative to certain commercial mobile services; to provide for  
4 disclosure of device location information"

5 AMENDMENT NO. 2

6 On page 1, line 5, delete "device"

7 AMENDMENT NO. 3

8 On page 1, line 12, delete "**Wireless telecommunications**" and insert "**Commercial mobile  
9 service**"

10 AMENDMENT NO. 4

11 On page 1, delete lines 16 and 17 and insert:

12 "**B. Upon receipt of an electronic or other written request of a law enforcement  
13 agency, a provider of commercial mobile services, as defined by 47 U.S.C.  
14 332(d), shall provide device location**"

15 AMENDMENT NO. 5

16 On page 2, line 1, change "**wireless telecommunications device**" to "**commercial mobile  
17 service device**"

18 AMENDMENT NO. 6

19 On page 2, lines 3 and 4, change "**wireless telecommunications**" to "**commercial mobile  
20 service**"

21 AMENDMENT NO. 7

22 On page 2, line 6, change "**an individual**" to "**the user of the commercial mobile service  
23 device**"

24 AMENDMENT NO. 8

25 On page 2, delete line 7 and insert:

26 "**C.(1) All providers of commercial mobile services registered to do**"

27 AMENDMENT NO. 9

28 On page 2, lines 11 and 12, change "**Subsection A of this Section. Such**" to "**the provisions  
29 of this Chapter. The**"

30 AMENDMENT NO. 10

31 On page 2, line 13, change "**or**" to "**and**"

1 AMENDMENT NO. 11

2 On page 2, delete lines 15 through 17 and insert:

3 **"emergency contact information for all providers of commercial mobile services**  
4 **and shall make such information immediately available to all law enforcement**  
5 **agencies in the state."**

6 AMENDMENT NO. 12

7 On page 2, delete line 21 and insert:

8 **"in this Chapter shall prohibit a provider of commercial mobile services"**

9 AMENDMENT NO. 13

10 On page 2, delete lines 24 through 29 and on page 3, delete lines 1 and 2 and insert:

11 **E. Any release of information made in accordance with the provisions**  
12 **of this Chapter shall be made in a manner respectful of a user's right to privacy**  
13 **as provided by law."**

14 **§844.10. Immunity for providers of commercial mobile services**

15 **No person shall have a cause of action against any provider of**  
16 **commercial mobile services, its officers, employees, agents, or other"**
