

Amendment to HB 319-FN

1 Amend the title of the bill by replacing it with the following:

3 AN ACT authorizing Friends of Seabrook Rail Trail to issue decals for multi-use plates and
4 establishing an oversight commission on multi-use decal plates.

6 Amend the bill by replacing all after section 1 with the following:

8 2 New Section; Oversight Commission on Multi-use Decal Plates. Amend RSA 261-B by
9 inserting after section 9 the following new section:

10 261-B:10 Oversight Commission on Multi-use Decal Plates.

11 I. There is established an oversight commission on multi-use decal plates. The commission
12 shall:

13 (a) Periodically review the status on approved organizations to ensure that they are
14 meeting reporting requirements and are still active and eligible.

15 (b) Review proposed decal designs from approved organizations to ensure compliance
16 with current standards.

17 (c) Make recommendations for repealing issuing authority for defunct or out of
18 compliance organizations.

19 (d) Review reports on the revenue from and the number of multi-use decal plates issued.

20 (e) Receive feedback from the division of motor vehicles on proposed program
21 modifications.

22 II.(a) The members of the oversight commission shall be as follows:

23 (1) Three members of the house of representatives, appointed by the speaker of the
24 house of representatives, who shall be members of the standing committee having jurisdiction over
25 transportation.

26 (2) One member from the senate, who shall be a member of the standing committee
27 having jurisdiction over transportation.

28 (3) One representative of the department of safety, appointed by the commissioner of
29 the department of safety.

30 (b) Legislative members of the oversight commission shall receive mileage at the
31 legislative rate when attending to the duties of the commission.

1 (c) The terms of legislative members shall be coterminous with their terms of office.
2 Legislative members may be reappointed consistent with the requirements of subparagraphs II(a)(1)
3 and (2).

4 III. The members of the oversight commission shall elect a chairperson from among the
5 members every 2 years. The first meeting of the commission shall be called by the first-named house
6 member. The first meeting of the commission shall be held within 45 days of the effective date of
7 this section. Three members of the commission shall constitute a quorum.

8 IV. The oversight commission shall make a report every 2 years beginning on November 1,
9 2020, together with its findings and any recommendations for proposed legislation to the speaker of
10 the house of representatives, the president of the senate, the house clerk, the senate clerk, the
11 governor, and the state library.

12 2 New Paragraph; Multi-Use Decal Plates; Approval by Oversight Commission. Amend RSA
13 261-B:2 by inserting after paragraph V the following new paragraph:

14 VI. New decals shall be subject to approval by the oversight commission on multi-use decal
15 plates, established in RSA 261-B:10.

16 3 Effective Date. This act shall take effect upon its passage.
