**PROPOSED AMENDMENTS TO  
HOUSE BILL 3075**

On page 1 of the printed bill, line 2, after the semicolon delete the rest of the line and delete lines 3 and 4 and insert “creating new provisions; amending sections 1, 2, 3, 5, 7 and 8, chapter 650, Oregon Laws 2015; and prescribing an effective date.”.

Delete line 6 and insert:

**SECTION 1.** Section 8, chapter 650, Oregon Laws 2015, is amended to read:

**“Sec. 8.** Sections 1 to 7 [*of this 2015 Act*], **chapter 650, Oregon Laws 2015, and section 8 of this 2021 Act** are repealed January 2, [2022] **2028**.

**SECTION 2.** Section 1, chapter 650, Oregon Laws 2015, is amended to read:

**“Sec. 1.** As used in sections 1 to 7 [*of this 2015 Act*], **chapter 650, Oregon Laws 2015:**

“(1) ‘Agricultural land’ means land used for the production of livestock for commercial sale or land that is cultivated, planted or irrigated for the production of domestic crops.

“(2) ‘Eligible land’ means agricultural land, forestland or mixed farm and forest use land.

“(3) ‘Eligible petitioner’ means an owner of 10 or more acres of eligible land.

“(4) ‘Forestland’ has the meaning given that term in ORS 477.001.

1 “(5) ‘Livestock’ means cattle and other bovines, sheep, goats, horses and  
2 other domesticated animals that are raised for the purpose of providing meat  
3 or other products for human consumption or use or for other commercial  
4 sales.

5 “(6) ‘Predatory animals’ means animals listed in ORS 497.655 and bears,  
6 bobcats and red foxes.

7 **“(7) ‘Prevent, reduce and mitigate damage to property from  
8 predatory animals’ includes both lethal and nonlethal methods of  
9 prevention, reduction and mitigation.”.**

10 In line 7, delete “2” and insert “3”.

11 On page 2, line 22, delete “3” and insert “4”.

12 In line 43, delete “4” and insert “5”.

13 On page 3, line 22, delete “5” and insert “6”.

14 Delete lines 44 and 45 and insert:

15 **“SECTION 7. Section 8 of this 2021 Act is added to and made a part  
16 of sections 1 to 7, chapter 650, Oregon Laws 2015.**

17 **“SECTION 8. A county that collects charges incurred by landowners  
18 pursuant to sections 1 to 7, chapter 650, Oregon Laws 2015, for the  
19 actual cost to the county of preventing, reducing and mitigating  
20 damage to property from predatory animals shall make reasonable ef-  
21 forts to use nonlethal methods to prevent, reduce and mitigate the  
22 damage before using lethal methods.**

23 **“SECTION 9. This 2021 Act takes effect on the 91st day after the  
24 date on which the 2021 regular session of the Eighty-first Legislative  
25 Assembly adjourns sine die.”.**
