15 "(b) Revenues generated from pari-mutuel events conducted
16 on the state fairgrounds shall be deposited in a state
17 fairgrounds construction and maintenance account, which is
18 hereby created within the state fair account. Funds in the state
19 fairgrounds construction and maintenance account shall be
20 expended only for capital construction costs for and maintenance
21 of a flat track for live horse racing events. Any funds in the
22 state fairgrounds construction and maintenance account after
23 construction and maintenance of a flat track for live horse
24 racing events shall only be used for major maintenance and
25 capital construction projects on the state fairgrounds and are
26 continuously appropriated to the account for those purposes. No
27 revenues in the account shall be used for any other purpose.
28

29 (c) Any live or historic pari-mutuel events on the state
30 fairgrounds may be conducted by a pari-mutuel permittee
31 authorized under W.S. 11-25-105. Any contract the board enters
32 into pursuant to this subsection shall:
33

34 (i) Be subject to the competitive bid process as
35 provided in W.S. 9-2-1016(b)(iv)(A) through (C). Any contract
36 may authorize the pari-mutuel permittee to conduct live and
37 historic pari-mutuel events on the state fairgrounds;
38

39 (ii) Provide that the amount remitted to the state
40 fairgrounds construction and maintenance account shall be not
41 less than the amount provided in W.S. 11-25-105(b)(iii) and may
42 provide for additional amounts remitted to the account as the
43 state fair board and permittee may agree upon.

1 (d) The board shall periodically audit the records and
2 practices of any permittee with whom the board contracts for
3 pari-mutuel events at the state fairgrounds. Any permittee with
4 a contract with the board shall provide the board a right of
5 access to all records regarding revenues, profits, expenses and
6 losses associated with pari-mutuel events held on the state
7 fairgrounds.
